GENERAL

How will A. Schulman be integrated into the LyondellBasell brand? Will the brand/naming of A. Schulman products change?

Following the completion of the acquisition, LyondellBasell will form a new business segment called Advanced Polymer Solutions (APS). This new segment includes LyondellBasell's legacy polypropylene compounds (PPC) business, the A. Schulman assets, *Catalloy* and polybutene-1. For now, LyondellBasell will not change the naming convention or branding of the A. Schulman products.

Will LyondellBasell keep the full A. Schulman portfolio or divest parts?

It is too early to speculate on any potential divestitures at this time. LyondellBasell continuously evaluates its businesses and product portfolios to best meet customer needs and deliver shareholder value

Does LyondellBasell have additional acquisition plans for the polymers business?

It is too early to speculate on any additional acquisitions for the polymers business at this time. However, LyondellBasell will always consider its customers' needs, opportunities in the M&A market and value for its shareholders.

How will A. Schulman legal entities be structured (including those performing sales)?

At closing, all of A. Schulman's subsidiary companies automatically become LyondellBasell subsidiaries because of the merger of applicable parent companies. For now, LyondellBasell does not plan to make any significant changes to its legal entity structure as a result of the completion of this acquisition.
